Members registered as Candidates:

No exemption fee R 1890. Partial exemption (this means allowing COET or other VA membership discount) R1640

Discount for being an COET Member thus R 250.

ECSA never shows the full fee and the discount with the reduced total on any of their invoices. They show only the bottom-line figure, so recipients are never sure if discount has been allowed or not. Therefore members must check any invoice they receive from ECSA to ensure that the discounted figure is there!

A copy of your membership letter or a CPD certificate from COET can be used to prove COET membership. CPD certificates for the past year were sent to members (but are not actually required by Candidates). CPD certificates for the current year will only be sent out after April.

No 4. News from ECSA.

18 Feb 2022.

CEO dismissed following a disciplinary enquiry.

The Engineering Council of South Africa's (ECSA) Sixth Term Council at a special meeting held on Thursday, 17 February 2022 unanimously adopted the dismissal of suspended Chief Executive Officer (CEO), Mr Sipho Madonsela. The termination of employment of Mr Madonsela follows his suspension on 11 June 2021 due to alleged acts of misconduct, which resulted in an investigation being conducted.

This was followed by a disciplinary process which was presided over by an independent Chairperson, Advocate Nazeer Cassim SC. In addition to his recommendation for the dismissal of Mr Madonsela, Advocate Cassim further recommended that the Council should forward his findings to the relevant authorities to avoid Mr Madonsela occupying a position as a director or senior employee in any similar entity or State Owned Enterprise (SOE) doing business with government including ECSA taking legal steps to recover the losses it has suffered at the hands of Mr Madonsela.

To ensure business continuity that is underpinned by continuous performance of the organisation, Mr Boitumelo (Cox) Mokgoro will continue in his role as Acting CEO, while the Council embarks on a recruitment process for a new CEO.

The Council and management team of ECSA remain committed to upholding its values of; professionalism, accountability to the public and profession, collaborative through working as a team with industry stakeholders, transparent through honest and open communications as well as innovative by making use of creative energies to achieve the mandate of the Council.

The Independent Communications Authority of SA (Icasa) has announced it wants to amend Regulation 8B of the End-User and Subscriber Service Charter Amendment Regulations of 2018 to read: "Unused data and data services obtained through either prepaid or post-paid channels shall not expire before expiry of a period of 6 months, except for promotional packages."

Heat Engine with no moving parts!

Engineers at MIT and the National Renewable Energy Laboratory (NREL) have designed a heat engine with no moving parts. Their new demonstrations show that it converts heat to electricity with over 40 percent efficiency --

a performance better than that of traditional steam turbines.

The heat engine is a thermophotovoltaic (TPV) cell, similar to a solar panel's photovoltaic cells, that passively captures high-energy photons from a white-hot heat source and converts them into electricity. The team's design can generate electricity from a heat source of between 1,900 to 2,400 degrees Celsius, or up to about 4,300 degrees Fahrenheit.

Caution. (Lab results so it's a long way from commercial applications yet).

Fortunately, it will never get closer than 1 billion miles from the sun, which is slightly farther from Earth than Saturn; that will be in 2031.
